GUEST SPEAKER: LAURA JULL

Laura is the Emergency Preparedness Coordinator for Saint Anthony's Hospital. She has 20 plus years in emergency management experience,. She was public information officer for Harrison Hospital, when 4 lives were lost at the Kona Village Fire. Media was terrible and she came to work for the Bremerton E.O.C. She worked for the hospital after 9/11. She went from county to hospital. Received certification as an Emergency Manager. Laura serves on several state committees.

Laura is working to prepare the hospital and stall to be prepared for any possible disaster. Dave Allen requested if a PEP-C representative could attend Laura's monthly meeting. She'll check and get back.

Problems: There is little time for training and rehearsing different types of disasters. Laura will concentrate on training the leaders. She has set up incident Management Team Members.

REPORTS:

David Allen: supplies water, food, oxygen, 500 gallons of water in storage and 88 beds. Food to feed people for 96 hours: Staff to bring own 3 day food for themselves. 5-7 days' supply of O2.

7 days of medication.

MRC just purchased 13 new Ham radios, LDS will train them on how to use. MRC is working with Assisted Living and Long Term care facilities to set up their needs. They can be useful in an emergency. David will send the director of Cottesmore to Laura.

Public Event: August 4th is the Police night out. Booth has been reserved for PEP-C & DEM. Ken would like us to have a great give away. Rent one of these machines: popcorn, snow cone or cotton candy. Possible food workers card needed. Motion was made to go ahead on the rental equipment. Motion was seconded.

Fox Island Disaster drill, August 8th, 11:00 to 5:00 pm.

Preparedness Fair: 14 invites went out. Receive for Ken. Company in Gig Harbor produces and markets tsunami life raft. Invite water storage, care facilities and any group in the community, and schools food vendors.

Local Radio will announce this fair. Schools will allow flyer to be brought home and how to work it out.
