PEP-C Fair Vendor Contract Terms

This contract is between the applicant (Vendor) and Peninsula Emergency Preparedness Coalition (PEP-C).

- 1) PEP-C will ensure the Vendor be provided with 1- 8 ft table (or the equivalent) and two chairs per purchased space.
- 2) Vendor will pay \$50 per space or \$60 with power, payable no later than April 15, 2023. Make checks payable to PEP-C and send them to the address at the top of the letter. Set-Up time is 8AM.
- 3) Vendor shall not offer any raffles, drawings or games of chance that have not been previously approved in writing by PEP-C.
- 4) Food vendors are responsible for ensuring they have the appropriate permits.
- 5) Vendor equipment and supplies must be removed from the premises by 4-22-23, 4PM.
- 6) PEP-C reserves the right to restrict and/or remove Vendors from the event without a refund, if Vendor's activities and/or products were misrepresented in this application, or are deemed unsuitable, unsafe or objectionable by PEP-C or Gig Harbor High School. This includes, but is not limited to: obscenity or objectionable material, excessive noise, odors, mess, inappropriate conduct, objectionable printed or visual materials, animals, and/or disruptions to the good order of the fair and/or other Vendors.
